What does the NAP-GSP do?

Programme Objective: To strengthen institutional and technical capacities for iterative development of comprehensive NAPs.





- Supports requesting countries with one-on-one technical assistance on demand to get started on the NAP process
- Sensitizes national teams on tools to support key steps of the NAP process through regional trainings
- Facilitates exchange of lessons and knowledge through South-South and North-South cooperation

Types of support provided by NAP-GSP



Supports existing efforts in relation to climate change adaptation planning, funding frameworks and prioritization of options.




It reviews sectoral and cross-sectoral priorities at the national, sub-national and local levels.




Focuses the needs of countries to initiate the different steps to identify, finance and implement the necessary adaptation measures in the medium and long term.

Snap-shot of NAP process in countries

MALAWI: Officially launched the NAP process and established a cross-ministerial NAP task force (Ministry of Planning, sectoral ministries and Ministry of Environment).

CAMBODIA: Identified building blocks of the NAP process as the CCCSP and CCCAP, and climate fiscal framework. Six priority areas for implementing adaptation identified under three work-streams: steering, implementing and monitoring the NAP process.

BANGLADESH: Prepared a detailed methodological note and road map for the NAP process and has identified activities; detailed scenarios, analyzing Bangladesh's Specific Vulnerability (by sector), visualizing adaptation needs in vulnerable sectors and integration of the NAP with national development pathways NIGER: Directions for NAP are identified as a focus on skills development, institutional capacity building, supporting coordination and steering of adaptation, building an effective information platform, mainstreaming in Vision 2035, and strengthening CCA mainstreaming and implementation with local level governance structures.

D.R. Congo: Is developing a road map for the NAP. The focus will be put on strengthening a strategic framework for the NAP through the setting up of a coordination mechanism, raising awareness and building capacities of key stakeholders at national level, as well as implementing a more comprehensive NAP process in pilot provinces.

Current Status

NAPGSP Support to LDCs (Phase 1)

- 2 million USD GEF-LDCF
- Active since 2013
- Support to LDCs based on the support requested

Extension of NAP-GSP support to LDCs (Phase 2)

 Started in November 2016 until 2019.

NAP-GSP support to developing countries

- Expansion of the programme to include non-LDCs.
- USD 4.5 million from SCCF
- Started in July 2015 until 2018

Support to countries based on received requests:

- 22 requests received
- 1 sub-regional workshop for the Caribbean
- 1 regional workshop for Eastern Europe and Central Asia (Moldova)
- 1 regional workshop for Asia and the Pacific (Sri Lanka)
- 1 regional workshops for South America (Colombia)



2017 – Activities

- Continue with direct support to countries
- 5 regional workshops
 - Central America
 - Middle East and North Africa
 - Caribbean
 - Africa
 - Asia





2017 – Activities

- Development of materials and tools for capacity development on the following topics (jointly with UNITAR and other partners):
